

Existing Customer Offer (MBB1) ("the Offer")

The following terms and conditions apply to Three's MBB1 offer ("the Offer") and are in addition to and form part of the terms and conditions of the Three Service (including but not limited to those set out in the Smallprint guide and in the Price Guide including the Bill Pay terms and conditions of service and the terms and conditions of your price plan). In the event of any conflict, these terms and conditions shall prevail.

1. The Offer is open to existing Three Bill Pay Voice customers on either of Three Ireland (Hutchison) Limited or Three Ireland Services (Hutchison) Limited (excluding SIM Only voice plans) ("Eligible Voice Plan") who sign up to a new Broadband 2, Broadband 3, Broadband 4 or Broadband 5 plan (excluding SIM Only plans) ("Qualifying Broadband Plan"). The Offer is a 25% (inc vat) discount (the "Discount") off the cost of the Qualifying Broadband Plan standard monthly recurring charge ("MRC") for Minimum Term only. The Discount does not apply to any usage outside of your inclusive data allowance.
2. The Offer is applicable for Eligible Voice Plan customers who sign up to and remain on a Qualifying Broadband Plan for the Minimum Term only.
