

Samsung Miracle pre-registration competition February 2026

All customers who have registered on the Samsung pre-registration URL will be entered into the draw. There is no charge for entry. This Competition will take place between the Start Date and the Closing Date and you must enter according to these terms and within the Competition Dates to be entered in the draw.

Competition dates are February 16th 2026 to Feb 24th 2026 23:59pm inclusive.

Only one entry per individual per mobile number and email address.

The winner will be selected randomly from all eligible entries received as set out above. There will be one winner only. The winner will receive the following Prize:

- A pair of tickets to a gig of their choice in the 3Arena, subject to availability
- Including lounge access and an entertainment allowance of €100

The entertainment allowance is valid for the purchase of food and beverages only. Alcoholic beverages are available exclusively to guests aged 18 and over. 3Arena management reserves the right to refuse service at its discretion.

Three will not be responsible for any inability of a Prize winner to take up or claim the specified Prize. As the Prize requires attendance at a specific venue, the winner and any permitted companions will be solely responsible for travel to and from the venue and all other expenses as well as monitoring the event scheduling in case of change or cancellation.
