

Three Ireland Broadband Offer for Dunnes Stores Customers (“the Offer”) Terms and Conditions

Offer Dates: 20th July 2026 until 9th August 2026 or the date on which the 500 Dunnes Stores gift cards have been redeemed (“Closing Date”)

Eligibility Criteria: Offer available exclusively to Dunnes Stores customers who receive or are presented with the promotional offer through Dunnes app. Telesales offer only.

Eligibility Plans are as follows:

- 3 Broadband Select 5G Silver (24 months)
- 3 Broadband Select 5G Gold (Tech Install) (24 months)
- 3 Broadband Select 4G (24 months)

1. The following terms and conditions apply and are in addition to and form part of the terms and conditions of the Three Service (including but not limited to those set out in the customer agreement form (CAF) issued to you at point of connection and in the Price Guide and the terms and conditions of your Price Plan).

2. In the event of any conflict, the (Customer Agreement Form) CAF terms and conditions shall prevail.

3. The Offer runs during the Offer Dates set out above until the specified Closing Date, subject to these terms.

4. This Offer is not available for upgrading Three customers or any other customer types outside of those set out in Eligibility Criteria above.

5. The Offer is as follows:

Eligible customers who sign up to either 3 Broadband Select 5G Silver, 3 Broadband Select 5G Gold or 3 Broadband Select 4G will receive three months free. This promotional discount will be applied automatically from months 2 to 4 of the minimum term. Pricing of Eligible plans are as follows;

- 3 Broadband Select 5G Silver - €39 per month and a 24-month minimum term applies. Each April a monthly price increase of €3 shall apply.

- 3 Broadband Select 5G Gold - €39 per month and a 24-month minimum term applies. Each April a monthly price increase of €3 shall apply.

Technical Installation required – Eligible customers must not allow anyone else (other than Three or its agents) to interfere with or to move or handle the Equipment before installation in any way. Your agreement commences when the Equipment is supplied to you but you will only be in a position to avail of the Service once Equipment is installed by Three or its agents further to the schedule agreed. You will not be charged for the Service before Equipment is installed by a technician.

- 3 Broadband Select 4G - €29.99 per month and a 24-month minimum term applies. Each April a monthly price increase of €3 shall apply

To avail of the Offer, Eligible Customers must access the Offer through the Dunnes Stores app and complete and submit the expression of interest form on the dedicated Three landing page. Submission of the expression of interest form does not constitute sign up to the Offer. The Three Telesales Team will contact the Eligible Customer within two working days of submission of the form. The Eligible Customer must complete the sign up to one of the Eligible Plans during that call in order to avail of the Offer.

The first bill must be paid before the three months free promotional discount is applied. 40 Days after completing the offer and joining Three on one of the plans listed above, customers will receive a one off €100 Dunnes Stores voucher via SMS to the mobile number associated with their Three account.

6. Subject to coverage and location. Speeds may vary. ROI Only.

7. Data Roaming is excluded from the Price Plans. For the avoidance of doubt the Price Plans will only work within the Republic of Ireland. The Price Plan is not a mobile offering and accordingly it does not fall within the scope of Regulation (EU) No 531/2012 (the Roaming Regulations).
