

## **Business Half Price MRC Promo 3<sup>rd</sup> July to 30<sup>th</sup> September 2020**

These reduced monthly recurring charge (MRC) for certain customers as described (“Promotion”) terms are in addition to the Small Print Terms for Three Ireland (Hutchison) Limited (“Three”) and the Three business terms on three.ie together with any other terms provided to you as part of your application process.

The Promotion is available to new and upgrading customers who sign up to one of 3 Business Starter SIMO, 3 Business Essential SIMO, 3 Business Multi Starter SIM, 3 Business Starter 24M, 3 Business Plus 24M, 3 Business Unlimited 24M, 3 Business Multi Starter 24M, 3 Business Multi Extra 24M, 3 Business Multi Plus 24M and 3 Business MBB UNLTD 24M plans (“Eligible Customers”) between 3<sup>rd</sup> July and 30<sup>th</sup> September 2020 (“Promotion Period”).

It is a condition of this Promotion that Eligible Customers agree to pay amounts due to Three by direct debit and receive bills in electronic format.

The Promotion is available through all sales channels. All monthly recurring charge amounts are ex VAT and are per individual subscriber on the account.

### **Eligible Customers signing up to 3 Business Starter SIMO**

Eligible Customers signing up to 3 Business Starter SIMO will have a monthly recurring charge of €12.50 applied (“Discounted MRC”) from the date of first connection or upgrade until 31<sup>st</sup> December 2020 (“Discounted MRC Period”).

From 1<sup>st</sup> January 2021 (regardless of when during Promotion Period the customer connected or upgraded), the monthly recurring charge applicable to Eligible Customers shall be €25 (“Standard MRC”).

### **Eligible Customers signing up to 3 Business Essential SIMO**

Eligible Customers signing up to 3 Business Essential SIMO will have a monthly recurring charge of €15 (“Discounted MRC”) applied (“Discounted MRC”) from the date of first connection or upgrade until 31<sup>st</sup> December 2020 (“Discounted MRC Period”).

From 1<sup>st</sup> January 2021 (regardless of when during Promotion Period the customer connected or upgraded), the monthly recurring charge applicable to Eligible Customers shall be €30 (“Standard MRC”).

### **Eligible Customers signing up to 3 Business Multi Starter SIM**

Eligible Customers signing up to 3 Business Multi Starter SIM will have a monthly recurring charge of €12.50 (“Discounted MRC”) applied from the date of first connection or upgrade until 31<sup>st</sup> December 2020 (“Discounted MRC Period”).

From 1<sup>st</sup> January 2021 (regardless of when during Promotion Period the customer connected or upgraded), the monthly recurring charge applicable to Eligible Customers shall be €25 (“Standard MRC”).

### **Eligible Customers signing up to 3 Business Starter 24M**

Eligible Customers signing up to 3 Business Starter 24M will have a monthly recurring charge of €22.50 (“Discounted MRC”) applied from the date of first connection or upgrade until 31<sup>st</sup> December 2020 (“Discounted MRC Period”).

From 1<sup>st</sup> January 2021 (regardless of when during Promotion Period the customer connected or upgraded), the monthly recurring charge applicable to Eligible Customers shall be €45 (“Standard MRC”).

#### **Eligible Customers signing up to 3 Business Plus 24M**

Eligible Customers signing up to 3 Business Plus 24M will have a monthly recurring charge of €29.50 (“Discounted MRC”) applied from the date of first connection or upgrade until 31<sup>st</sup> December 2020 (“Discounted MRC Period”).

From 1<sup>st</sup> January 2021 (regardless of when during Promotion Period the customer connected or upgraded), the monthly recurring charge applicable to Eligible Customers shall be €59 (“Standard MRC”).

#### **Eligible Customers signing up to 3 Business Unlimited 24M**

Eligible Customers signing up to 3 Business Unlimited 24M will have a monthly recurring charge of €40 (“Discounted MRC”) applied from the date of first connection or upgrade until 31<sup>st</sup> December 2020 (“Discounted MRC Period”).

From 1<sup>st</sup> January 2021 (regardless of when during Promotion Period the customer connected or upgraded), the monthly recurring charge applicable to Eligible Customers shall be €80 (“Standard MRC”).

#### **Eligible Customers signing up to 3 Business Multi Starter 24M**

Eligible Customers signing up to 3 Business Multi Starter 24M will have a monthly recurring charge of €15 (“Discounted MRC”) applied from the date of first connection or upgrade until 31<sup>st</sup> December 2020 (“Discounted MRC Period”).

From 1<sup>st</sup> January 2021 (regardless of when during Promotion Period the customer connected or upgraded), the monthly recurring charge applicable to Eligible Customers shall be €30 (“Standard MRC”).

#### **Eligible Customers signing up to 3 Business Multi Extra 24M**

Eligible Customers signing up to 3 Business Multi Extra 24M will have a monthly recurring charge of €17.50 (“Discounted MRC”) applied from the date of first connection or upgrade until 31<sup>st</sup> December 2020 (“Discounted MRC Period”).

From 1<sup>st</sup> January 2021 (regardless of when during Promotion Period the customer connected or upgraded), the monthly recurring charge applicable to Eligible Customers shall be €35 (“Standard MRC”).

#### **Eligible Customers signing up to 3 Business Multi Plus 24M**

Eligible Customers signing up to 3 Business Multi Plus 24M will have a monthly recurring charge of €22.50 (“Discounted MRC”) applied from the date of first connection or upgrade until 31<sup>st</sup> December 2020 (“Discounted MRC Period”).

From 1<sup>st</sup> January 2021 (regardless of when during Promotion Period the customer connected or upgraded), the monthly recurring charge applicable to Eligible Customers shall be €45 (“Standard MRC”).

**Eligible Customers signing up to 3 Business MBB UNLTD 24M**

Eligible Customers signing up to 3 Business MBB UNLTD 24M will have a monthly recurring charge of €12.50 (“Discounted MRC”) applied from the date of first connection or upgrade until 31<sup>st</sup> December 2020 (“Discounted MRC Period”).

From 1<sup>st</sup> January 2021 (regardless of when during Promotion Period the customer connected or upgraded), the monthly recurring charge applicable to Eligible Customers shall be €25 (“Standard MRC”).

Additional charges on top of either the Discounted MRC or Standard MRC may apply depending on your usage.

If you cancel your price plan during or after the Promotion Period you will be required to pay the monthly recurring charges due for the remaining months of your minimum term (24 months except for SIM Only plans).

Three reserves the right to not to apply the Discounted MRC for either part or whole of the Promotion Period to customers whose account is in arrears.
