

FWA/MBB Three stores Wexford/Ennis campaigns promotion February 2026

These reduced monthly recurring charge (MRC) for certain customers as described (“Promotion”) terms are in addition to the Small Print Terms for Three Ireland (Hutchison) Limited (“Three”) and the price plan terms on three.ie together with any other terms provided to you as part of your application process.

The Promotion is available to (a) new fixed wireless access (FWA) customers who are not existing Three voice customers signing up to either 3 Broadband Unlimited 5G Gold or 3 Broadband Unlimited 5G Silver (“Eligible New Customers FWA”) and (b) Existing Three Bill Pay or Three Prepay or 48 customers signing up to either 3 Broadband Unlimited 5G Gold or 3 Broadband Unlimited 5G Silver, in the Three store Wexford or the Three store Ennis only (“Eligible Existing Customers FWA”) and (c) new 4G Broadband customers who are not existing Three voice customers signing up to 3 Broadband Unlimited 4G (“Eligible New Customers MBB”) and (d) Existing Three Bill Pay or Three Prepay or 48 customers signing up to 3 Broadband Unlimited 4G (“Eligible Existing Customers MBB”), in the Three store Wexford or the Three store Ennis only between 12th February 2026 and 25th February 2026 (“Promotion Period”).

It is a condition of this Promotion that Eligible Customers agree to pay amounts due to Three by direct debit and receive bills in electronic format.

The Promotion is available during the Promotion Period only in the Three stores mentioned above.

Eligible New Customers FWA

Eligible New Customers signing up to either 3 Broadband Unlimited 5G Gold or 3 Broadband Unlimited 5G Silver during the Promotion Period will have a monthly recurring charge of €30 (“Discounted MRC”) applied from the date of first connection for 24 months only (“Discounted MRC Period”).

After the Discounted MRC Period the monthly recurring charge applicable to Eligible Customers shall be €39 (“Standard MRC”).

Each April your applicable monthly charge whether the Discounted MRC or the Standard MRC will be subject to a price increase of €3.

Eligible Existing Customers FWA

Eligible Existing Customers signing up to either 3 Broadband Unlimited 5G Gold or 3 Broadband Unlimited 5G Silver during the Promotion Period will have a monthly recurring charge of €25 (“Discounted MRC”) applied from the date of first connection for 24 months only (“Discounted MRC Period”).

After the Discounted MRC Period the monthly recurring charge applicable shall be €39 (“Standard MRC”).

Each April your applicable monthly charge whether the Discounted MRC or the Standard MRC will be subject to a price increase of €3.

Eligible New Customers MBB

Eligible New Customers MBB signing up to 3 Bill Pay Unlimited 4G will have a monthly recurring charge of €25 (“Discounted MRC”) applied from the date of first connection for 24 months (“Discounted MRC Period”).

After the Discounted MRC Period the monthly recurring charge applicable shall be €29.99 (“Standard MRC”).

Each April your applicable monthly charge whether the Discounted MRC or the Standard MRC will be subject to a price increase of €3.

Eligible Existing Customers MBB

Eligible Customers signing up to 3 Bill Pay Unlimited 4G will have a monthly recurring charge of €25 (“Discounted MRC”) applied from the date of first connection for 24 months (“Discounted MRC Period”).

After the Discounted MRC Period the monthly recurring charge applicable shall be €29.99 (“Standard MRC”).

Each April your applicable monthly charge whether the Discounted MRC or the Standard MRC will be subject to a price increase of €3.

Additional charges on top of either the Discounted MRC or Standard MRC may apply depending on your usage.

If you cancel your price plan during or after the Promotion Period you will be required to pay the monthly recurring charges due for the remaining months of your minimum term

Three reserves the right to not to apply the Discounted MRC for either part or whole of the Promotion Period to customers whose account is in arrears.

This Promotion is not available with any other offers, promotions or discounts or with any other price plans or via any other sales channels.
