

Three Smartwatch Bundle Terms & Conditions

The following terms and conditions apply to the Three Smartwatch Bundle comprising your Smartwatch payment (“Three watch Add-on”) and the monthly service Add-on payment (“Smartwatch Share”) together the “Smartwatch Bundle” and govern your purchase and use of a smartwatch device (“Device”) with the Three Smartwatch Share Add-on (the “Service”). These terms will apply in addition to the Three terms of Service at <https://www.three.ie/pdfs/legal/smallprint.pdf> which apply to your Three telecommunications service and which also apply to your use of the Smartwatch Bundle.

1. Eligibility

1.1 The Smartwatch Bundle is available to “Eligible Customers” (“you”) as defined below. Eligible Customers are Three mobile customers who satisfy each of the following:

i)

an active Three Bill Pay account on one of the following Bill Pay plans only (“Qualifying Account”);

a. Three Select Essentials 5G

b. Three Select Freedom 5G

c. Three Loyalty 150 5G

d. Three Loyalty 300 5G

e. Three Loyalty Unlimited 5G

f. Three SIM Freedom 24m

(each a “Qualifying Plan”); and

ii)

who have a compatible smartphone device

and

iii) Eligible Customers must connect to the Smartwatch bundle at the point of Qualifying Plan and device upgrade or within 30 days thereafter

and

iv) Eligible Customer’s Qualifying Account must be not be in arrears or have been in arrears in the six month period prior to you connecting to the Three Smartwatch Bundle

1.2 By electing to pay for the Device via 24-month contract in twenty-four (24) equal instalments you will not be charged any additional fees or interest for electing to pay for the Device this way. You confirm that Three has not

invited you by advertisement to avail of such payment arrangement for the purchase of the Device.

1.3 By electing to pay for the Device over a 24-month contract in twenty-four (24) equal instalments you confirm that you will not be charged any interest and you confirm that you have not been invited by way of advertisement to connect to the Three Smartwatch Bundle.

2. Rules

A 24-month term (the “Term”) applies to the Three Smartwatch Bundle.

2.1 . You can share your Qualifying Plan inclusions and mobile number with your compatible Device through Three Smartwatch bundle. This means you can use your Device to make and receive calls and use data on the Three network in the Republic of Ireland when you're away from your phone. You must have the Smartwatch Share Add-on to consume Three services available on your Qualifying Plan on your Device.

2.3. The Three Smartwatch bundle comprises a monthly charge for the Device for a fixed 24 month term (Three watch Add-on) and also a monthly charge payable for the Sharer Add-on which enables you to consume your voice and data allowances from your Qualifying Plan on your Device. Where you do not already have the Three Smartwatch Share Add-on on your Qualifying Account you must add it when buying the Three Smart watch.

2.4 At the end of the 24 month Term Three will cease adding the Three watch Add-on charge to your monthly Three bill.

2.5 Termination of your Qualifying Plan including but not limited to porting your mobile number to another provider during the Term outside of your 14 day distance contract cancellation window referred to below will lead to immediate cancellation of your Three watch Add-on and remaining payments comprising the number of remaining Three watch Add on payments in term multiplied by the monthly Watch Add-on charge will become due immediately as a cancellation charge.

2.6. A separate monthly charge applies to the Smartwatch Share Add-on which links your Qualifying Plan to your Device. Roaming is not available with the Smartwatch Sharer Add-on. If you cancel the Smartwatch Sharer Add-on before the end of the Term, you must continue to pay Three watch Add-on monthly charges for the Term.

Your monthly payment amount is as agreed at point of connection for the Three Watch Add-on and where you do not already have the Smartwatch Share Add-on when you agree to the Three Watch Add-on you must also add the Smartwatch Share Add-on. After the Term expires, your agreement for the Three Watch Add-on will cease and you will no longer pay for the Device.
