

## **Former ID Mobile customers on €5 monthly recurring charge plan moving to handset plan promotion 2018**

These reduced monthly recurring charge (MRC) for former ID customers currently on the €5 MRC ("Former ID customers") Promotion ("Promotion") terms are in addition to the Small Print Terms for Three Ireland (Hutchison) Limited ("Three") and the Bill Pay terms on three.ie together with any other terms provided to you as part of your application process.

The Promotion is available to Former ID Customers who sign up to either 3Mini Flex Max, 3 Classic Flex Max or 3 Unlimited Flex Max on a 24 month minimum term ("Eligible Customers") between 26<sup>th</sup> October 2018 and 28<sup>th</sup> February 2019.

It is a condition of this Promotion that Eligible Customers agree to pay amounts due to Three by direct debit.

This offer is not available on three.ie and is only available via Carphone Warehouse stores, Three stores and the telesales channel.

### **Eligible Customers signing up to 3 Mini Flex Max**

Eligible Customers signing up to 3 Mini Flex Max will have a monthly recurring charge of €15 ("Discounted MRC") for three months only, commencing from their second bill ("Promotional Period").

From their fifth bill, the monthly recurring charge applicable to Eligible Customers shall be €30 ("Standard MRC").

### **Eligible Customers signing up to 3 Classic Flex Max**

Eligible Customers signing up to 3 Classic Flex Max will have a monthly recurring charge of €25 ("Discounted MRC") for three months only, commencing from their second bill ("Promotional Period").

From their fifth bill, the monthly recurring charge applicable to Eligible Customers shall be €45 ("Standard MRC").

### **Eligible Customers signing up to 3 Unlimited Flex Max**

Eligible Customers signing up to 3 Unlimited Flex Max will have a monthly recurring charge of €30 ("Discounted MRC") for three months only, commencing from their second bill ("Promotional Period").

From their fifth bill, the monthly recurring charge applicable to Eligible Customers shall be €60 ("Standard MRC").

Additional charges on top of either the Discounted MRC or Standard MRC may apply depending on your usage.

If you cancel your Price Plan during the Promotional Period you will be required to pay the MRC due for the remaining months of your Minimum Term.

Three reserves the right to not to apply the Discounted MRC for either part or whole of the Promotional Period to customers whose account is in arrears.

This Promotion is not available with any other offers, promotions or discounts.

A discount will also be applied to selected handsets ranging from up to €100 for Eligible Customers signing up to 3 Mini Flex Max, up to €150 for Eligible Customers signing in to 3 Classic Flex Max , and up to €200 for Eligible Customers signing up to 3 Unlimited Flex Max. Where a handset eligible for a discount is priced at less than the discount, no cash refund will be applied for any excess of the discount and the handset will not have an upfront charge applied
