

## Samsung Galaxy S7 Free Virtual Reality Device Terms and Conditions

Offer Dates: 9am on Monday 22<sup>nd</sup> February 2016 for preorder until the date when stocks of the Virtual Reality device run out /8<sup>th</sup> March 2016 for retail until the date when stocks of the Virtual Reality device run out (“Closing Date”)

Eligibility Criteria: This offer is available to new and upgrading customers of Three Ireland (Hutchison) Limited and Three Ireland Services (Hutchison) Limited (each known as “Three”) subject to the below;

1. The following terms and conditions apply to Three’s Samsung Galaxy S7 Free Virtual Reality device offer (“the Offer”) and are in addition to of the terms and conditions of the Three Service (including but not limited to those set out in the Smallprint guide or the General Terms and in the Price Guide including the Bill Pay or Prepay terms and conditions of service and the terms and conditions of your Price Plan).

3. To be eligible to avail of the Offer you must either;

5. For Eligible Preorders VRs will be received by customers with their Samsung Galaxy S7 on 8<sup>th</sup> March 2016. For Eligible Retail Purchases, customers will receive the VR with their Samsung Galaxy S7.
  
6. In the event that you are permitted to return your device under applicable legal or regulatory provisions, you agree to return the VR to Three with your device. Where

the VR experiences any damage or wear and tear beyond a reasonable degree, you agree to reimburse Three for the cost of the VR.
