

## **Samsung A5-17/Samsung S7 Promotion July/Aug 2017**

These Samsung A5-17/Samsung S7 Promotion (“Promotion”) terms are in addition to the Small Print Terms for Three Ireland (Hutchison) Limited (“Three”) and the Bill Pay terms on three.ie together with any other terms provided to you as part of your application process.

The Promotion is available to new Three Bill Pay customers (subject to moving your number from another network with the below exception) and existing Three customers moving from Prepay to Three Bill Pay with an Eligible Connection, who connect to Unlimited Flex Max only on a 24 month minimum term with the Samsung S7 or to Classic Flex Max with the Samsung A5-17 (“Eligible Customers”).

Neither customers moving their number from Three Ireland Services (Hutchison) Limited to Three Ireland (Hutchison) Limited, except existing Three customers moving from Prepay to Three Bill Pay with an Eligible Connection, nor upgrading customers of Three are eligible to avail of this Promotion.

The Promotion is available between 1<sup>st</sup> July and 31<sup>st</sup> August 2017 only.

It is a condition of this Promotion that Eligible Customers agree to pay amounts due to Three by direct debit.

Eligible Customers signing up to Unlimited Flex Max with the Samsung S7 will have a monthly recurring charge of €45 (“Discounted MRC”) for 6 months only, commencing from their second bill (“Promotional Period”).

From your seventh bill, the monthly recurring charge applicable to Eligible Customers shall be €60 (“Standard MRC”).

Additional charges on top of either the Discounted MRC or Standard MRC may apply depending on your usage.

Eligible Customers signing up to Classic Flex Max with the Samsung A5-17 will have a monthly recurring charge of €30 (“Discounted MRC”) for 6 months only, commencing from their second bill (“Promotional Period”).

From bill seven of your Minimum Term, the standard recurring monthly charge of €55 (“Standard Monthly Charge”) per month shall apply.

If you cancel your Price Plan during the Promotional Period you will be required to pay the Three Standard MRC for any remaining months which you may be eligible to receive the Discount which applies to your Price Plan and for any period thereafter within your Minimum Term multiplied by the number of months left on the Minimum Term. No Discount will be applied to cancellation charges.

Three reserves the right to not to apply the Discounted MRC for either part or whole of the Promotional Period to customers whose account is in arrears.

Three reserves the right to withdraw the Promotion either generally or in respect of any particular Customer at any time and to vary or amend any element of the Promotion at any time without

further notice. These terms and conditions may be varied or amended by Three for any valid commercial, technical or operational reason.
