Offer Dates: 1st November 2016 – 31<sup>st</sup> January 2017 ("Closing Date")

Eligibility Criteria: This offer is available to new Three Bill Pay Mobile Broadband customers signing up to one of the following plans only – Three Broadband 1, Three Broadband 2, Three Broadband 3, Three Broadband 4, Three Broadband 5("Eligible Plans") on an 18 month minimum term in a participating store during the Offer Dates.

- 1. Three Ireland's MBB TBYB Offer is available to new Three Bill Pay Mobile Broadband customers signing up to one of the following plans only Three Broadband 1, Three Broadband 2, Three Broadband 3, Three Broadband 4, Three Broadband 5 on an 18 month minimum term in a participating store during the Offer Dates
- 2. You will be eligible to avail of the TBYB Offer subject to these terms and within 30 days of connection ("Trial Period").
